- 2) The rate quoted shall be inclusive of all taxes. The CST, Octroi, sales tax and any other levy applicable may be shown separately in the tender; otherwise it will be presumed that the price offered is inclusive of all taxes whatever may be.
- 3) The tender will be evaluated items wise.
- 4) Government payment towards the procurement made is done post delivery and inspection of the items.
- 5) Details of the items along with the make, brand, model, etc should be clearly mentioned in the tender; else the item shall be liable for rejection.
- 6) The tender shall be valid for 180 days from the date of opening it.
- 7) The items will be inspected for acceptance in the presence of your representative and will be accepted if it confirms to the specification mentioned in the Annexure.
- 8) In case of rejection of the items, the supplier shall be responsible to make arrangements to lift the same at his own cost and risk immediately.
- 9) Transportation, installation and demonstration shall be at the cost of the supplier.

- 10) In the event of any question, dispute or any difference arising, the same shall be referred to the sole arbitrator of a person to be appointed by the Governor of Goa. The award of the arbitrator so appointed shall be final.
- 11) This office reserves the right to accept or reject any or all the tenders without specifying any reason thereof.
- 12) This office reserves the right to place order for part/full quantity mentioned in the tender for the purchase of the items as the case may be.
- 13) The extension of the time limit will be granted at the discretion of the Principal of the Institute on genuine grounds based on a written request by the supplier.
